## Revision Proposal to Department/Program Challenge Exams

<u>Purpose</u>: To allow departments the authority to determine and place students into courses which match students' demonstrated levels of skill/knowledge in the subject matter since EGSC does not offer corresponding exams on campus.

Departments and degree programs may develop challenge exams that demonstrate attainment of desired learning outcomes for a course within the program and/or the general education sequence at the college level. A department and/or program cannot offer a challenge exam if there is a corresponding CLEP, AP, DANTES (DSST), or IB exam.

Revision suggested: A department and/or program cannot offer a challenge exam if there is a corresponding CLEP, AP, DANTES (DSST), or IB exam given on the campus.

Objective: Revising the above policy will allow the **SpanIsh Credit by Exam** proposal which was approved by the Faculty Senate in 2016 but was tabled by the APCC to be re-evaluated and implemented.
